The proposal seeks consent for a modest single-storey extension to the existing dwelling, providing a self-contained one-bedroom unit with associated bathroom and living accommodation. The extension is designed to meet the needs of a disabled occupant, ensuring accessible and functional living space that integrates with the existing property.

The new accommodation will be supported by the existing kitchen facilities within the main dwelling, enabling shared use and continuity of household arrangements.
